Mary Beth Buchanan, President, Americas and Global Chief Legal Officer, Merkle Science

Mary Beth Buchanan is the Executive Vice President Americas and Global Chief Legal Officer at Merkle Science, where she leads the company's expansion into the Americas and directs the company's global legal, regulatory, and government affairs efforts. Mary Beth brings over three decades of deep expertise at the intersection of federal law enforcement, global interagency cooperation, corporate compliance, digital assets, and emerging regulatory frameworks. Prior to joining Merkle Science, Mary Beth was the Chief Legal and Compliance Officer at Menai Financial Group, the Global Chief Legal Officer at Bitstamp, and the General Counsel at Kraken.

Mary Beth became active in the digital currency space in late 2013 while a partner at Bryan Cave Leighton Paisner. Bernhard Kowatsch is the Head of the Innovation Accelerator at the United Nations World Food Programme (WFP), which he founded in 2015. The Accelerator has been awarded the "Best workplace for innovators" in 2021 and 2020 by Fast Company. Bernhard also was one of four finalists for Fast Company's Innovative Leader of the Year 2021. The Accelerator sources, nurtures and scales start-ups and non-profits that disrupt global hunger. In 2020, the innovation and startup portfolio positively impacted the lives of 3.7 million people (+160% vs. 2019) and has raised a total of \$118M of grant funding.

The Accelerator has supported more the 100 innovations with funding, runs SDG accelerators for external partners such as the Bill & Melinda Gates Foundation, Humanitarian Grand Challenges and other UN Agencies in different areas, and just celebrated its 5-year anniversary. The now-60+ member team represents over 30 countries and speaks more than 20 unique languages.

Bernhard is a regular speaker at tech conferences and global events on tech for good, blockchain, artificial intelligence, social entrepreneurship and technologies disrupting global hunger, e.g. Mobile World Congress, AI For Good, SXSW, World Economic Forum, XPRIZE and numerous UN and government events.

Prior to starting the Accelerator, Bernhard co-founded the award-winning ShareTheMeal app that crowdsources funding for WFP. This leading innovation has raised over 115 million meals (\$60M+) for hungry children worldwide (as of August 2021), and was named as an App of the Year for 2020 by both Apple and Google.

Bernhard also build up WFP's Internal Management Consulting unit based in Rome, and was previously a Project Leader at the Boston Consulting Group (BCG) for global tech and industrial goods companies. He holds three Masters' degrees from HEC Paris and Vienna University of Business and Economics.

and Innovation, Dr. Sindi was voted one of the BBC's top 100 Women 2018, a list of inspiring and influential women from around the world.

Dr. Sindi graduated with honors from King's College London in Pharmacology in 1995, and was the first woman from the Gulf region to obtain a PhD in biotechnology from the University of Cambridge.

In 2017, Dr. Sindi was appointed as Chief Scientific Advisor to the President of the Islamic Development Bank (IsDB). In this role, she has put science, technology and innovation at the heart of IsDB's work, making it a powerful driver of economic growth and sustainable development. He completed a Master's Degree in Artificial Intelligence at Imperial College London. His master's thesis was on blockchain technology, during which he co-founded Aventus.

QR Capital is the biggest 100% crypto asset regulated fund manager in Latin America, that launched the first Bitcoin and Ether ETFs in Latin America, listed in Brazil Stocks Exchange (B3). QR Capital is also developing regulated digital asset projects in Brazil. Fernando is Global Blockchain Business Council's ambassador in Brazil and also a member of the Financial Innovation Laboratory (LAB), a multi-sector forum created by the Brazilian Development Association, the Inter-American Development Bank and the local Securities Commission, which has been discussing innovative solutions to improve the Brazilian financial and capital markets infrastructure and efficiency. Fernando pursues MBA degree from the University of Pittsburgh (USA) and training at Oxford Blockchain Program at Said Business School (UK).

Andre Portilho, Head of Digital Assets, BTG Pactual

U.S. Representative Josh Gottheimer (D-NJ), Member, U.S. House of Task Force on Financial Technology

Josh Gottheimer represents New Jersey's Fifth Congressional District in the northernmost part of the state, which includes parts of Bergen, Passaic, Sussex, and Warren counties. He was first sworn in on January 3, 2017, and is now in his third term in office.

In Congress, Josh serves on two Committees, including the House Financial Services Committee, where he is a member of the National Security, International Development and Monetary Policy Subcommittee and the Investor Protection, Entrepreneurship, and Capital Markets Subcommittee. Josh also serves on the House Homeland Security Committee, where he is a member of the Intelligence and Counterterrorism Subcommittee and the Transportation and Maritime Security Subcommittee.

In January 2017, Josh was elected Co-Chair of the bipartisan Problem Solvers Caucus, where he works to bring the group of 29 Democrats and 29 Republicans together across party lines to find areas of agreement on key issues including lowering taxes, cutting health insurance premiums, and improving infrastructure to help the American people. He was re-elected Co-Chair of the Problem Solvers Caucus in January 2021. Just two months into his first term, Josh passed his first amendment in the House, which was later signed into law, to accelerate the hiring of post-9/11 veterans at the Department of Veterans Affairs. Last Congress, Josh was among the top ten Members with the most amendments considered on the House floor.

As a member of the House Homeland Security Committee, Josh realizes that the safety and security of the nation is at a critical juncture, with rapidly evolving threats from foreign and domestic terrorists, and homegrown violent extremism. He advocated for, and was successful in, the removal of Twitter accounts affiliated with Foreign Terrorist Organizations, including Hamas and Hezbollah. Josh is committed to lowering taxes and getting Fifth District residents a better return on the tax dollars they already send to Washington. Last year alone, by working with Fifth District mayors, councils, first responders, and towns, Josh has helped the Fifth District claw back \$448 from Washington for every household in the Fifth District — a 108% increase from what the District has historically received. These dollars help first responders protect our communities while offsetting the strain on local budgets and property tax bills.

For his support for pro-growth policies and bipartisan governing, the U.S. Chamber of Commerce awarded Josh its Spirit of Enterprise Award every year he has served, as well as its first ever Jefferson—Hamilton Award for Bipartisanship. For his consistent work on both sides of the aisle and as Co-Chair of the Problem Solvers Caucus, Josh was recognized as the most bipartisan Democrat in the House by the Lugar Center and the McCourt School of Public Policy at Georgetown University. Josh has also received the Jefferson-Lincoln Award from the Panetta Institute for Public Policy.

During the COVID-19 crisis, Josh has been laser focused on fighting for families, hospitals, small business, frontline workers, and communities to help get the Fifth District the resources it needs. During the height of the pandemic, Josh was instrumental in leading the Problem Solvers Caucus and a bipartisan group of Senators in writing and passing the Consolidated Appropriations Act, 2021, which provided \$908 billion in COVID-19 relief to families, small businesses, and frontline workers. When COVID-19 hit nursing and veteran homes, Josh was on the frontlines every day meeting with hospitals, doctors, nurses, and officials. Josh was able to secure National Guard members, medical strike teams, emergency funding, and other resources for long-term care facilities in the Fifth District.

Beyond the pandemic, Josh is continuing to work hard to ensure North Jersey families are safe and healthy. Since 2017, Josh has worked with stakeholders and leaders on every level to ensure that Fifth District students and communities have access to lead-free clean drinking water, especially in schools. In 2019, Josh was critical in implementing the State of New Jersey's new online database that provides parents and communities with easy-to-access and up-to-date information on dangerous lead water in their children's schools.

Josh is continuing to protect the environment by fighting the illicit dumping of waste and toxic materials, including working closely with local leaders to combat the Vernon Dirt Pile and illegal dumpers.

Gottheimer has also been dedicated to combating antisemitism, strengthening the historic U.S.-Israel relationship, and securing passage of bipartisan language reaffirming the Obama-Biden Administration's ten year U.S.-Israel Memorandum of Understanding (MOU). Josh was raised in North Caldwell, the son of a preschool teacher and a small business owner. Growing up, Josh worked in his father's store and, like your average New Jersey kid, treasured summer vacations at the Jersey Shore. His first concert was at the Meadowlands to see the one and only Bruce Springsteen!

Josh graduated from West Essex High School before attending the University of Pennsylvania, later becoming a Thouron Fellow at Oxford, and then paid his way through Harvard Law School.

After finishing college, Josh went on to work in the Clinton White House as one of the youngest presidential speechwriters in history. Josh wrote speeches on topics ranging from the global economy to technology and innovation to combating crime; he also helped draft two State of the Union Addresses.

After leaving the White House, Josh worked at the Ford Motor Company, where he helped rebuild the iconic auto company's image and worked on the first American hybrid. Josh was also a Senior Advisor to the Chair of the U.S. Commission on Civil Rights and published the book "Ripples of Hope: Great American Civil Rights Speeches."

Josh later served as Senior Counselor to the Chairman at the Federal Communications Commission. During his tenure, he was the first Director of Office of Public-Private Initiatives, partnering with private companies to break through roadblocks and solve national problems. These partnerships saved taxpayers money while helping law enforcement, boosting digital education, and creating jobs. Josh worked on cybersecurity, broadband adoption, combating cell phone theft, creating a new public safety emergency alert system, and expanding wireless spectrum. Josh used that experience to help create a nonprofit, JerseyOn, that has expanded access to high-speed internet for low-income New Jersey students to help them compete in the 21st Century economy.

Before running for Congress, Josh worked at Microsoft as General Manager for Corporate Strategy, where he focused on the company's expansion into the cloud, e-commerce, and privacy. He was also a member of both the Ridgewood and New Jersey Chambers of Commerce, the Rutgers Business School Advisory Board, and was a visiting fellow at Princeton University's Center for Information Technology. He also taught history at the University of Pennsylvania.

Josh's approach to public service is rooted in his experience in both the public and private sectors. During his time working with President Clinton, Dr. Mary Frances Berry, Senator Frank Lautenberg, and Speaker Thomas Foley, he saw that, by seeking common ground, it's possible to find a bipartisan path forward without compromising your core values. Josh firmly believes that it doesn't matter if an idea comes from the Democratic or Republican side of the aisle, only whether it will help the communities and people of the Fifth District.

Josh now lives in Wyckoff, New Jersey with Marla, his wife who was a federal prosecutor, and their two young children, Ellie and Ben.

Dr. Esper Kallas, Researcher, Global Pandemic Shield (recorded remarks)

Dr. Esper Kallás is Full Professor at the Department of Infectious and Parasitic Diseases in the School of Medicine of the University of Sao Paulo and Director of the Clinical Trials Unit at the Hospital das Clinicas of the University of Sao Paulo, the largest Hospital in South America.

Throughout the COVID-19 crises, Esper Kallás has been a reference for authorities and the media on the combat against the Covid-19 pandemic. He has been working since the early 1990s on studies of HIV infection and other infectious diseases, focusing on the areas of immunopathology, treatment and prevention.

Dr. David Watkins, Researcher, Global Pandemic Shield (recorded remarks)

Dr. David Watkins is Professor of Pathology at the George Washington University, US; and a former faculty member of Harvard University. David is also a fellow in the American Academy of Microbiology and recipient of the Elizabeth Glaser Scientist Award.

His research object is the eradication of infectious diseases.
