



Dr. Matthias Artzt, Senior Legal Counsel, Deutsche Bank

Dr. Matthias Artzt is a certified lawyer and senior legal counsel at Deutsche Bank AG since 1999. Prior to joining Deutsche Bank he worked as a lawyer at a law firm in Stuttgart, Germany.

He has been practicing data protection law for many years and was particularly involved in the implementation of the GDPR within Deutsche Bank AG. He advises internal clients globally regarding data protection issues as well as complex international outsourcing agreements involving data privacy related matters and regulations.

He is a graduate of the University of Tübingen, where he obtained his Doctor of Law degree. Moreover, he is a member of the International Association of Privacy Professionals (IAPP) and since January 2018 a Certified Information Privacy Professional/Europe (CIPP/E). Since January 2020 he is also a member of the European Advisory Board of the IAPP.

Matthias is the author of numerous articles on data protection law. Particularly, he is the co-editor and co-author of the recently released Handbook of Blockchain Law (published by Wolters Kluwer).

Further, he is a regular panel speaker on various national and international conferences, seminars and webinars, e.g. at the Central Bank of Brazil in 2018. He has an in-depth knowledge of the GDPR and its interfaces with other topics such as Cloud Computing, Big Data, AI, Blockchain, US-Cloud Act and PSD2.



Locknie Hsu, Professor, Singapore Management University

Locknie Hsu is a full Professor of Law at the School of Law, Singapore Management University. She received her legal training at the National University of Singapore and Harvard University, and is a member of the Singapore Bar. She has received several teaching awards and in 2017, she was conferred the Outstanding Service Award by the ASEAN Law Association (ALA), in which she is Coordinator of the Trade and Investment Group. She was attached to Singapore's Ministry of Trade & Industry for a period, to participate in free trade agreement

negotiations, before returning to academia.

Locknie specializes in international trade and investment law, including areas such as paperless trade, FTAs, digital commerce, business applications of technology, and developments relating to the Belt and Road Initiative (BRI), including its Digital Silk Road. She currently teaches Contract Law to students in the Computing & Law programme, and an elective course which she pioneered in 2019, Law & Digital Commerce, to law students.

In March 2018, the Final Report in a research project led by Locknie, “Improving Connectivity Between ASEAN’s Legal Systems to Address Commercial Issues”, containing recommendations on matters such as Digital Economy and connectivity issues in ASEAN, was published.

Locknie is a member of the International Law Association and a member of the Singapore Executive Council of the ASEAN Law Association.

In 2014, the Markell Administration recruited Andrea to launch Global Delaware for the State of Delaware. The following year, she founded the Delaware Blockchain Initiative (DBI), the first of its kind blockchain endeavor designed to deploy blockchain technology in government and enact blockchain-friendly legislation. The DBI gave rise to the "Blockchain Amendments" to Delaware's General

Corporation Law which authorize corporations to maintain their corporate records, including stock ledgers, on a blockchain.

Andrea received her undergraduate degree from Brown University. She attended Delaware Law School, graduating magna cum laude. Following her clerkship for (former) Chancellor William Chandler III, of the Court of Chancery, Andrea joined the Wilmington office of a national law firm where she represented clients in litigation.

A few years later, global corporate services company CSC invited Andrea to join as Assistant General Counsel. Andrea was subsequently promoted to the newly-created position of Vice President Business Development, where she specialized in creating new revenue streams for the company.
