He is also a Co-Founder of Immunefi, a cybersecurity bug bounty platform for cryptocurrency projects that has prevented over \$20 billion in economic damage. Through Immunefi, he is also the Facilitator of the Immunefi Security Core Unit of the MakerDAO ecosystem, one of the pioneers of the DeFi space

together with its DAI stablecoin, where the core unit provides proactive security services and coordination.

Travin Keith is also a Co-Founder of STOKR, a fundraising platform that utilises blockchain technology through Ethereum, the Liquid Network by Blockstream, and Algorand, for the issuance of tokens representing financial instruments (security tokens). Other advisory positions include Obyte, a DLT platform utilising a directed acyclic graph (DAG) together with its Counterstake product, a decentralised DLT-agnostic bridge, and Neptune, a layer-one blockchain that leverages cutting edge cryptography to offer a set of features unique to any project in the space.

Other organisations Travin is involved with include Hyperledger, a Linux Foundation project, of which he co-authored the white paper titled "An Introduction to Hyperledger". He also contributed to the Blockchain4EU initiative by the European Commission and has consulted with a variety of government organisations. His ultimate ambition being to create a level-playing field on which all humanity would be empowered with equal access to digital assets and opportunities. Building on his success as co-founder and CEO of OANDA, famed for revolutionising forex trading. Richard has always drawn his inspiration from nature. He believes that today's financial systems are marred by inefficiencies that ultimately penalise everyday people. And that through ever-increasing digitisation, it is possible to mimic nature's perfect autoregulation and eliminate these inefficiencies. As such, it is his belief that eventually, markets will become entirely digitised with market making fueling systems with almost nonexistent exchange fees.

She is the first woman Chair of Science and Technology STOA Panel 2017-2022 and the Center for Artificial Intelligence.

As Vice President, Eva Kaili is the Chair for ICT Innovation Strategy, Informatics and Telecoms, has the responsibility of European Strategy and Policy Analysis Systems, Foresight, STOA, and Corporate Social Responsibility. She replaces the President with the European Business Associations, UN, OECD, WTO, and the region of Middle

East. Furthermore, she is in the Industry Technology Research and Energy, Economic and Monetary Affairs, Budget, and the AIDA committee. She launched the C4AI and its International Advisory Board and

established collaboration with the OECD Global Parliamentary Network in 2019. She was Chair of the Delegation of NATO\_PA 2014-2019.
